

Application to reduce or eliminate the waste fee

According to the Waste Act, a waste fee may be changed or left unlevied by application of the party liable to pay or by initiative of the authorities if the waste fee must be considered unreasonably high or low.

Eliminating the waste fee is only possible in case the property is in unlivable condition. When applying for the elimination of the waste fee, the applicant must prove the unusability of the property to the waste management authority with documents or photographs.
