

Application for use of a shared dry waste container, biowaste container, or composter

If they so wish, neighbouring properties may share a waste container (dry waste container, recycling container, biowaste container, or composter). Any share agreements in place between nearby properties must be notified in writing to Etelä-Karjalan Jätehuolto Oy.

If the properties in question are not neighbouring properties, or if the number of participants in the share agreement is more than five, a deviation permit must be applied for the share arrangement from the waste management authority. Using a shared waste container with another property does not eliminate the annual fees for the property (basic fee, official fee, and possible municipal surcharge).
